Grant Report.

- Weed Control- harvesting grant ended with small amount of leftover funds in our account.
- Stewards last year of grant. We hope to have stewards covering all three entry points, beginning as early as 6am on the weekends to catch tournament boats. Hoping for grant renewal next year
- Harvester- surface harvesting for Curly Pondweed to start in late May for 5-6 days (60 hrs). Also plan "bog" pick up just before the 4th of July. No date yet for suction harvesting.

- 7 Finger Lakes are involved in this initiative. Trying to get lake users to take the pledge which is available on OLPA website.
- May 2-7 is an educational week with numerous webcasts related to this message. OLPA has sponsored one done by Janet Allen at 10am, May 4.
  Margie will make sure this and others are recorded for future access
- Suggestions were made that we create a separate account to fund future speakers. Also, that the larger association develop a regional speakers board.

Wash Station

• Tim and Jim had a meeting with DEC and county representatives about putting the wash station at the SE end of the lake on the parking area connected with the Henderson property.

- This site would be convenient to all three lake access boat ramps with space to clean a boat/trailer and for one waiting in line.
- The DEC will cover all the equipment costs, including a storage shed, power washer type unit, and 550 gallon water reservoir similar to a station presently in use on Saranac Lake.
- The county will work on a responsibility plan for OLPA, assuming stewards will assist in operating the station. The unit has already been purchased so projected time for the start of operations is late this summer or beginning next summer.
